All technicians opening the refrigeration circuit in automotive air conditioning systems must now be certified in refrigerant recovery and recycling procedures to be in compliance with Section 609 of the Clean Air Act Amendments of 1990.

## Certify your technicians today...

More than 500,000 technicians have already enrolled in the MACS Worldwide certification program. The MACS Worldwide program has been approved by the U.S. EPA to meet technician certification requirements under Section 609 of the Clean Air Act Amendments of 1990. It is designed to help you comply with the law, protect the environment and conserve the supply of CFC-12 for future service. The technician is the key to the successful implementation of on-site refrigerant recovery and recycling. This program is designed to encourage proper equipment use and service procedures.

## How the MACS program works

- Complete the response form below and forward to MACS Worldwide, enclosing the appropriate fee (\$15 per technician).
- By return mail, MACS Worldwide sends copies of the self-study Certification Training Manual for Refrigerant Recycling & Service Procedures for Automotive Air Conditioning Technicians.
- After studying the manual, the enclosed test must be completed and returned to our contracted independent test scoring company in return envelope provided.
- The test scoring company will advise MACS of your score. If a passing score is attained, MACS will mail certification credentials, including a wall certificate and laminated wallet card.
- Persons not attaining a passing score on the first test will receive one re-test at no additional charge.
